WELCOME/AGENDA REVIEW

Project Director, Isabel Perez-Morina welcomed everyone to the eighth and last meeting of the Service Partnership for Children of High Conflict Families. The meeting facilitator, Janice Fleischer, reviewed the Agenda for the day (Exhibit A). All members of the Service Partnership introduced themselves.

AN OVERVIEW OF PROPOSAL AND STATUS OF APPLICATION

Ms. Perez-Morina described the Children's Trust application process for the upcoming collaborative work. The final proposal was originally due on November 15, 2007, but it was moved up by a month to October 12, causing some hard work to be done to complete the process in a timely manner. The plan submitted was contained in the meeting packets (Exhibit B). The application process was successful and a resolution to approve funding will be presented to the Children's Trust Program Services Committee this afternoon, and with their approval to the General Board on November 13th, 2007.

The new name of the project will be: *Bridging Families and Communities*, reflecting the family driven, community and strength based approach of this partnership and collaborative.

The model for the collaborative is the Wrap Around Model previously described at prior meetings. Each of the three focus areas reported on their section of the Plan.

<u>The Family Court section</u>: Lisette Sanabria, Director of Family Court Operations, and Linda Fieldstone, Family Court Services Supervisor, spoke regarding this section.

Page 11 of the Plan was provided to members for their information. There is an early triage component to the Plan. Recommendations can be made to case managers on families that might not need wrap around services. There is also an element for families with substance abuse.

<u>Domestic Violence Court section</u>: Maria Harris, Director of Domestic Violence Court, spoke on this section on behalf of the court and Ivon Mesa, Director of the Domestic Violence Intake Unit. Maria explained the process as it pertains to the referrals into the system of care from this point of entry.

<u>Shelters:</u> Isabel Perez-Morina spoke on behalf of Angela Diaz-Villadet, CEO of the Lodge, and explained how women with children entering shelter will be screened and referred into the system of care. Due to recent turnover in Miami-Dade County, Paula Bain, who represented the shelters in this partnership, is no longer working in that capacity. Project staff will be contacting Patricia Sims, Director of the SafeSpace shelters to bring her up to speed and reach an arrangement for screening and referral.

First Responders:

Members asked the following questions after the First Responders reported on their section:

- 1. Will fire and rescue be included as first responders?
 - a. Once we have decided on the pilot area, we will see if fire and rescue are interested in referring.
- 2. Will initial screening be kept so if a family is initially not identified as a Domestic Violence (DV) family, but then when they get to court it is discovered that they were DV?

a. Screening will be given only for those calls coming in as domestic violence.

Overall there is a commitment to the Trust that 400 families needing multiple services due to being high conflict will be identified and receive services. The other funded group is Children's Services.

A psychological evaluation will hopefully be added as an additional service over and above the medical intake. Many partners have additional services they provide routinely; they will be contacted to maximize the services available.

The Trust has limited original funding due to the budget situation in the current economic environment; therefore flex funding for money for families has been reduced but The Children's Trust may allow for the capacity to apply for an increase in funds if needed after a period of time.

Another issue is the identification of the family team. One member inquired if families come directly to providers/partners, can they refer them to the program? Ms. Perez-Morina responded by saying they were not sure yet since it may cause a "flood" of referrals.

It was noted that the collaborative should be looking for other funding as it moves forward so the collaborative is not only relying on the Children's Trust for funds.

It was suggested that the collaborative may want to use graduate programs to get the psychological evaluation done at the level of funds available (\$250.00 per person) since it is unlikely that private practitioners could be found who will do evaluations for that amount of money. Additionally, a member observed that adult and child evaluations are very different and must be conducted very differently; child evaluations take much longer and are more expensive due to the time involved.

We may want to look at whether a family can contribute any funds to this aspect and the \$250.00 could be added and thereby increase the funds available. Additionally, the school system may be willing to help if they are able. However, one member stated that there is often a waiting time within the school system which is very long and by the time the evaluation is done, major problems have arisen (crime, drop out, etc.).

The Courts are switching from psychological evaluations to mental health evaluations; it is important to ensure that the correct referral is happening.

All partners will be receiving a draft Memorandum of Understanding (MOU) for partners to take to their Boards/legal departments, etc. In addition a Memorandum of Intent (MOI) will be sent so they can be signed before the actual MOU is signed (which often takes a longer period of time).

CARE COORDINATION: FAMILY TEAM EXERCISE

Belinda Paulicin explained that Care Coordination is all about working as a Team (family, providers, community, collaborative). Collaboratives work on breaking down barriers, closing gaps, and increasing expertise. The beauty of a collaborative is that all members work on these issues together.

In order to demonstrate how this might work, Belinda Paulicn led the members in a Family Team Exercise. The members broke into 5 small groups. Each group was given a scenario (Exhibit C).

The groups discussed each member of the scenario family and what services/interventions should be considered including the strengths and weaknesses of the scenario family.

A lively discussion ensued, which included several comments and questions about the interpretation of calling in abuse/neglect to the DCF abuse hotline when children witness domestic violence. The collaborative agreed that this topic was an important community issue and that the partnership would take a key role in organizing an event to clarify issues and to bring together professionals from child welfare, domestic violence, and mental health to reach a uniform protocol.

BREAK

The members took a short break.

SUCCESS WITH COLLABORATIVES: EXAMPLES

Member Michelle Sweeting gave a report on a successful collaborative of which she is a part: the Community Empowerment Teams. This comes from a Committee on Violence in Broward and Dade Counties. The group wanted to address violence in non-traditional ways; to be unique. The Collaborative is currently in four areas of Miami-Dade County: 3 in South Dade and one in Liberty City. The Collaborative brings no money to the table; however they have brought in partners to assist like Police, mental health, housing, education, and social services.

Teams function out of office space donated in the communities and office supplies/equipment have been provided as well. They go door to door; tell about the Team and how and why it could be a benefit to the community and the problem of violence. Each member agency provides in kind contributions. Ms. Sweeting said it is a very exciting and rewarding program.

Member comments:

- 1. Who chairs the collaborative?
 - a. Jeffrey Gorley
- 2. Do you do immediate intervention?
 - a. Help with understanding the system and having an advocate in the community to assist with working through the system.
 - b. We come as a team; if as a team member the best thing for a family does not involve my agency, we still make sure it is done.
 - c. Enables the evaluation of the individual needs of each community; things that by contract or law they are not allowed to do (street parties, etc.) can be reviewed and help make good things happen for the community instead of just giving a blanket "no"; work with the community as unique.
- 3. What is the community involvement?
 - a. Walk throughs help
 - b. Tenant association meetings
 - c. Housing developments have rules and meetings
 - i. Currently reworking the model being used
- 4. Are representatives from the community seated on the panel/team?
 - i. They come to the meetings are not members of the Team.
 - ii. Plan is to do training to develop natural leaders.
- 5. Can you take referrals from that area from us?
